RESOLVE 1	Resolved, that SBCCD and SBVC cease construction of the New Applied Technology Building and redraws its floor plan as the current footprint involves the destruction of a sizeable portion of the Living Lab Garden thus diminishing adherence to SBVC's mission and SBCCD's Sustainability Plan and generating negative impact to current educational activities; and	With regard to this resolved, no action was taken by SBCCD and SBVC management on this matter.	Construction proceeded, thus demolition of a large portion of the Garden took place in August 2022.
RESOLVE 2	Resolved, SBCCD and SBVC re-evaluate and significantly improve the collegial consultation process, in light of the detrimental failure associated with the Living Lab Garden, and work with SBVC's stakeholders to ensure systematic and frequent input from impacted constituents on ongoing and future building planning, design, and project implementation; and	TBA (update in progress)	
RESOLVE 3	Resolved, that SBCCD and SBVC work with District Fiscal Services and SBVC's stakeholders to ensure immediate and concurrent establishment of an equivalent or better outdoor instructional site with adequate funding and planned consultation processes while construction of the New Applied Technology Building is taking place; and	May 2022, action was taken by both SBCCD and SBVC management to create a workgroup with Science Division faculty designees, landscape architects of the Tech Building Project (aka CP1 Project, Measure M), and District project management.	After several weekly and biweekly meetings for one year, a landscape design was developed for a restored garden site (a small portion of grass donated by the Athletics Director) North of the Gym building. Construction started Winter '23 and currently project is in its final phases (expected November'24). Though deadlines vary given the ground completion of the new tech building.
