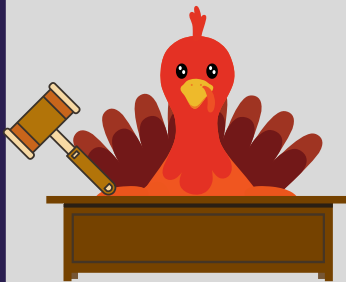


### Land Acknowledgement at SBCCD

## Common Course Numbering

Important updates regarding our college's implementation of the Common Course Numbering (CCN) initiative and to outline opportunities for faculty involvement in this critical process.

### **Funding and Administrative Update:**

- Our college has received \$543,043 in designated CCN funding from the state through our district
- The Board of Trustees has approved non-instructional hours for this work
- A core working group has already begun preliminary CCN implementation work
- We are now establishing a broader CCN Taskforce to develop a comprehensive spending plan.

**Current Status:** Our Curriculum Committee has been actively engaged with CCN implementation this term, following California Community Colleges Chancellor's Office (CCCCO) guidelines. Their work has laid essential groundwork for our next steps.

- Role of Academic Senate
  - As this initiative directly impacts curriculum, the Academic Senate will play a central role in overseeing the CCN implementation process
  - The Senate will review and approve the Taskforce's recommendations
  - Regular updates will be provided by Curriculum at Senate meetings to ensure transparency and gather faculty input.
